## Registration Types and Rates

- **Full Registration** provides a name badge required for entrance to ALL education sessions, all meals, and all social functions including the Monday President's Breakfast, Tuesday Breakfast, Tuesday Awards Luncheon, and Wednesday Breakfast.
- **Guest Registration** provides entrance to all education sessions and meal functions. "**Guest**" refers to a spouse/significant other or relative, NOT a business associate or staff colleague. A guest registration does not qualify for CEs with TDLR. Please be sure to include the guest's name.
- **One-day Registration** is available ONLY for 2026 TAAD member district staff, 2026 associate or affiliate TAAD members, 2026 participating conference donors and 2026 participating conference vendor staff.

For TAAD Member District and TAAD Associate/Affiliate Member registration rates to apply, 2026 membership dues must be paid in full by February 1, 2026.

## Cancellation and Refund Policy
